# **GDPR Privacy Policy**

# 1. GDPR Privacy Notice

The General Data Protection Regulations come into effect in the UK from 25 May 2018, replacing the Data Protection Act 1998.

This Privacy Notice sets out most of your rights under the new laws. As the Regulations come into effect and the Information Commissioners Office (ICO) update their rules and best practice, we will continually update this Notice.

#### 2. Who we are

North Oxford Association (NOA) runs the Community Centre in Diamond Place and the Pavilion in Cutteslowe Park.

#### 3. Collection of your Personal Information from center users

- 3.1. NOA may collect and use the following kinds of personal information through this website/form
- 3.2. Information about your use of our website including information obtained via cookies
- 3.3. information that you provide during the use of our services/registration process/joining of our mailing lists, including your name, email address and telephone number for the purpose of making electronic and other bookings for services
- 3.4. Information about electronic and other bookings for services made via our website including dates, times and locations of appointments
- 3.5. information that you provide by joining our membership, including your name, address, email address, telephone number, bank account details; and records of your membership fees payments
- 3.6. information that you provide for the purpose of feedback on our website and on any service provided by NOA and any other information that you send to NOA

#### 4. We are collecting data for the following reasons

- 4.1. We only collect data for the following reasons and provided that we have your consent
- 4.2. To communicate with you only when necessary or previously agreed upon
- 4.3. Processing is necessary for the performance of a contract or to take steps to enter into a contract and ensure you are correctly invoiced.
- 4.4. Processing is necessary for compliance with the Charity Commission, HMRC, Oxford City Council
- 4.5. NOA staff and administrators will be obligated to use that personal information in accordance with the terms of this privacy statement.
- 4.6. In addition to the disclosures reasonably necessary for the purposes identified elsewhere above, NOA may disclose your personal information to the extent that it is required to do so by law, in connection with any legal proceedings or prospective legal proceedings, national security and in order to establish, exercise or defend its legal rights.

#### 5. Securing Your Data

5.1. NOA will take reasonable technical and organisational precautions to prevent the loss, misuse or alteration of your personal information.

- 5.2. NOA will take reasonable technical and organisational precautions to store and process all personal information you provide in a secure manner.
- 5.3. NOA will take reasonable steps to ensure that any third party services we use that hold personal data have robust data protection policies

# 6. How long do we keep your personal data?

We will endeavor to keep data only for as long as we need it. This means that we will delete it when it is no longer needed. We will keep some records permanently if we are legally required to do so and may keep some other records for an extended period of time to follow best practice. For example, it is currently best practice to keep employment records for 5 years and financial records for a minimum of 3 years, to support HMRC audits.

#### 7. Your rights and your personal data

- 7.1. You have the right to access, correct, have erased, and object to processing your personal data. You can make any changes easily by telephone, email, or by post (see Contact Details below).
- 7.2. When exercising any of the rights, we may need to verify your identity for your security. Once we have received your request we will respond within one month.
- 7.3. For the right to access there are no fees or charges for the first request but additional requests for the same data may be subject to an administrative fee.
- 7.4. We will confirm whether this data has been deleted or processing has stopped or the reason why this cannot be done (for example because we need it for our legitimate interests or regulatory purpose(s)).
- 7.5. You have the right to lodge a complaint with the Information Commissioner's Office.
